### **1.1.4. How does the institution ensure that the curriculum bears thrust on national issues like environment, value education and ICT?**

#### **Environment:-**

5. Pupil teachers visit different places and generate awareness among people regarding protection of environment under community work.
6. Pupil teacher visit different places including village to not only generate awareness regarding environment but also encourage them to do the same by practically doing it like cleaning the roads and cleansing the drains.

#### **Value Education:-**

1. Value education includes cultural, religious educational, moral and democratic values. These values are inculcated through these values are inculcated through various co-curricular activities organized by the college like skits, group songs, nukkad natak, awareness generating camps etc.
2. Value education is also one of the optional papers prescribed in the syllabus.
3. Educational CDs bases on value and place education are shown to the pupil teachers from time to time.
4. Different guest lectures are also organized by the college.

#### **ICT:**

1. R.KG. organized special class for computer literacy to make the P.T. computer

The college as rich computer lab with 45 terminals. Special classes for computer literacy are organized. All the faculty members are computer literate and provide CDs. and PPTs. The time-tables, Academic Calender, co-curricular Calender, Holiday calender etc. are displayed on our website at the starting of the session Along with the different notices from time to time. Also, these are-mailed to PTs on their individual / personal emails.

**1.2 Academic Flexibility**

**1.2.1. How does the institution attempt to provide experiences to the PTs so that teaching becomes a reflective practice?**

One of the main objective of B.Ed. training is the develop teaching skills and provide proper experience to the PTs. R.K.G. follows and promotes different teaching method such as discovery learning, problem-based learning, active learning, co-operative learning, project based learning, inductive teaching, case based instructions etc.

Through Action Research, PTs. get the experiences of actual classroom problems and also how to solve those issues. Different projects are give to group of PTs to have the experience of collaborative group learning.

Before going for actual practice in teaching, Micro teaching and simulated teaching is conducted in the college for developing proper teaching skills.

PTs visit the school, observe daily routine and also interact with the permanent teaching staff of the school where they have to go for practice-in-teaching. During Practice-in-teaching, PTs get first hand information and real experience of school working, academic as well as managerial aspects. PTs. take one class of each subject and teach for 10 days thus, completing 10+10=20 teachings / classes in one phase of practice - in - teaching or two months. During this period the PTs not only take classes but also participate in all the curricular and co-curricular activates such as morning assembly, orgainzing sports day / annual day, Parents - Teacher's meeting etc.

In the second phase of teaching, along with the regular classes, PTs also conduct class tests, Action research, maintain attendance and teacher's diary. This give proper experience and exposure to them.

Also, PTs have to present at least one topic from their syllabus in the college. All the cultural events of the college are organized by the PTs to have the experience of organizing events in the schools.

**1.2.2. How does the institution provide for adequate flexibility and scope in the operational curriculum for providing varied learning experiences to the PTs both in the campus and in the field?**

R.KG. follows the syllabus and curriculum prescribed by University of Lucknow but does not follow it rigidly. It inculcate different event and activities to provided varied learning experiences to the P.T. such as:-

- Organizing workshops and Seminars in the college.
- Encouraging the PTs to participate in different co-curricular activities organized by other colleges.
- Teaching through multimedia and computer aided instructions, CDs, internet etc.
- Giving different projects and surveys.
- Organizing different activities like sports day, fresher's party, send off party etc. to make the curriculum more interesting
- Organize scouts and guides training Comp.
- Organizing local tour and out stationed tour to develop feeling of cooperation, sense of responsibility etc. among PTs.
- Encouraging the students to work for community and nation by organizing community work such as Adult education, gave girl child, Plantation activity etc.
- Conducting different competitions such as dance competition, singing competition, cooking without fire, collage, rangoli etc. different academic and cultural activities and competitions.
- Celebrating different events like, world Literacy day, Hindi Divas, Women's Day, World Aid's Day Etc.
- College gives liberty to opt any of the optional papers provided by the University to PTs.
- College conducts unit tests, prefinal theory exams and Mock psychology Practical for the students so that they can analyze their knowledge.

- College also has the provision of remedial and revision classes for the PTs.
- College provides vocational and educational guidance to the PTs. if required.
